Official Rules

- **THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH FACEBOOK, INSTAGRAM, OR TIK TOK.**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES PARTIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The Airheads Impoosible Sweepstakes (the “Sweepstakes”) is open only to legal residents of the fifty (50) United States and the District of Columbia who are of the age of majority in their state of residence (18 or older in most states; 19 in Alabama and Nebraska). Employees, officers and directors of Perfetti Van Melle USA, Inc. (“Sponsor”), Realtime Media LLC (“Administrator”), Highdive Advertising, LLC, Wavemaker Media, and their respective parent companies, affiliates, subsidiaries, advertising, promotion, marketing, fulfillment, and judging agencies, and any influencers, creators, or other individuals or entities involved in the development, production, execution, or distribution of this Sweepstakes (collectively, the “Sweepstakes Parties”), their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses, and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. Void where prohibited by law. All federal, state, and local laws and regulations apply. By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these “Official Rules” and the decisions of Sponsor, including the interpretation of these Official Rules, administration of the Sweepstakes, selection of the winners, and Sponsor’s exercise of discretion, which will be final, non-appealable, and binding in all respects.
2. **TIMING:** The Sweepstakes begins at or about 12:00:01 a.m. Eastern Time (“ET”) on June 15, 2026, and ends at 11:59:59 p.m. ET on August 31, 2026 (the “Sweepstakes Period”).

The designated computer clock of the Administrator is the official time-keeping device in the Sweepstakes.

3. **HOW TO ENTER:** To enter the Sweepstakes, you must create and submit an original image generated using an artificial intelligence tool or platform (each, an “AI Tool”) that depicts an Airheads-inspired dream pool (the “Entry”). For purposes of these Official Rules, an “AI Tool” means any software, application, or platform that generates images, artwork, or visual content based on user prompts or inputs.

Each Entry must: (i) be original to the entrant; (ii) be created solely by the entrant using an AI Tool; (iii) comply with all content requirements and restrictions set forth in these Official Rules, including, without limitation, the content restrictions described in Section 3; and (iv) not include any content that infringes upon or violates the rights of any third party, including, without limitation, intellectual property rights, rights of publicity, or privacy rights.

By submitting an Entry, entrant represents and warrants that: (a) entrant has all rights, licenses, and permissions necessary to submit the Entry and grant the rights described in these Official Rules; (b) the Entry does not incorporate, and was not generated using prompts that include, any third-party

intellectual property, brand names, logos, copyrighted material, or the name, image, likeness, or voice of any person (living or dead), except as expressly permitted herein; and (c) the Entry complies in all respects with these Official Rules. Entries that do not comply may be disqualified in Sponsor's sole discretion.

Without limiting the foregoing, each Entry must comply with the following content requirements (the "Content Requirements"):

AI-generated content and the prompts used to create it must not include:

- Depictions of any humans
- Animals consuming Airheads (animals not consuming Airheads are permitted)
- Music that entrant does not have rights or permissions to use
- Names, logos, characters, or other indicia of any brand, product, or service
- The name or likeness of any person, living or dead
- Extreme profanity
- References to, characters from, or names or images of movies, television shows, books, or other programs
- Recognizable man-made locations, landmarks, or signage (excluding natural locations such as national parks)
- Obscene content or any content including violence or gore
- Controversial or sensitive subject matter, including political views, sexual situations or mature themes, illegal activity, or offensive or discriminatory matter
- Depictions of dangerous, negligent, reckless, or risky acts or behavior
- Content that disparages or reflects negatively on the Sponsor or its products

In addition, when inputting prompts into an AI Tool, entrants must not use or upload any Sponsor intellectual property or third-party intellectual property as part of the prompt, including, without limitation, trademarks, brand names, logos, copyrighted materials, or the name, image, or likeness of any person.

During the Sweepstakes Period, once you have created your Entry, you may enter the Sweepstakes using the following methods:

A. Facebook Entry: On Facebook, take the following steps:

- i. Log in to your Facebook account and become a follower of **@airheadscandy**. Be sure your Facebook account is set to public.
- ii. Create and publish a post to your Facebook timeline featuring your Entry. Your post must include the hashtag **"#ImpoolsibleSweepstakes"** in the caption.
- iii. Entries must be publicly viewable through the end of the Sweepstakes Period to be eligible. If you successfully complete all required steps, you will receive one (1) entry into the Sweepstakes per qualifying post, subject to the entry limit below.

B. Instagram Entry: On Instagram, take the following steps:

- i. Log in to your Instagram account and become a follower of **@airheadscandy**. Be sure your Instagram account is set to public.
- ii. Create and publish an original post to your Instagram feed featuring your Entry (as defined above). Your post must include the hashtag **"#ImpoolsibleSweepstakes"** in the caption and tag **@airheadscandy**.

iii. Entries must be posted from a public account and remain publicly viewable through the end of the Sweepstakes Period to be eligible. If you successfully complete all required steps, you will receive one (1) entry into the Sweepstakes per qualifying post, subject to the entry limit below.

C. TikTok Entry: On TikTok, take the following steps:

i. Log in to your TikTok account and become a follower of **@airheads**. Be sure your TikTok account is set to public.

ii. Create and publish a post to your TikTok feed featuring your Entry. Your post must include the hashtag **"#ImpoossibleSweepstakes"** in the caption.

iii. Entries must be publicly viewable through the end of the Sweepstakes Period to be eligible. If you successfully complete all required steps, you will receive one (1) entry into the Sweepstakes per qualifying post, subject to the entry limit below.

All Entries must comply with the Content Requirements set forth above and any other requirements described in these Official Rules. Entries that do not comply may be disqualified in Sponsor's sole discretion.

Be sure your social media account is set to public, and you are following the Sponsor's associated social handle for at least sixty (60) days after the end of the Sweepstakes Period for winner notification purposes. Due to how the social platforms operate, Sponsor may not receive entries from entrants with "private" account settings. You may return your account(s) to "private" any time after winners have been verified.

To participate and enter Sweepstakes via Instagram, Facebook, and/or TikTok, you must have a non-private account on the applicable platform. You may create a Facebook, Instagram OR TikTok account for free by visiting the respective platform's website or downloading the applicable app from your mobile device's app store. Creation of an account requires agreement and compliance with the platform's terms of service and privacy policy. If you do not agree to the applicable platform's terms of service and privacy notice, you cannot create a Facebook account and/or an Instagram account to participate in this Sweepstakes.

The Sweepstakes Parties are not responsible for technical difficulties of any kind, any unavailability of a social platform, or for false, incorrect, changed, incomplete or illegible contact information.

Limit: One (1) unique entry per person, per day, per platform (Instagram, Facebook, and TikTok) during the Sweepstakes Period. For purposes of these Official Rules, a "unique" Entry means an Entry that is materially different from any previous Entry submitted by the same entrant, as determined by Sponsor in its sole discretion. Entries that are duplicative, substantially similar, or generated using the same or similar prompts or minor variations thereof may be disqualified. Attempts made by the same individual to earn more than the stated number of entries by using multiple or false contact information, accounts or otherwise may result in disqualification.

Entries generated by script, computer programs, macro, programmed, robotic, or other automated means (including the use of artificial intelligence tools in a manner that violates these Official Rules, including, without limitation, use of bots, automation, or bulk submission tools) are void and may be disqualified. Entries that are in excess of the stated limit(s), incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Those who do not follow all instructions or abide by these Official Rules or other instructions of Sponsor may be disqualified. Entries submitted by those who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. In the event of a dispute over the identity of an entrant, Entry will be deemed submitted by the authorized account holder of the social media

account used to submit the Entry, provided that person is eligible. Any potential winner may be required to show proof of being the authorized account holder. In the event that a dispute regarding the identity of the individual who submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

4. **SWEEPSTAKES DRAWINGS:** On or about September 1, 2026, the Administrator will conduct a random drawing to select one (1) potential winner from among all eligible entries received in accordance with these Official Rules.
5. **ODDS:** Odds of winning the prize depend on the total number of eligible entries received during the Sweepstakes Period.
6. **WINNER NOTIFICATION/PRIZE CLAIMING:** Potential winner will be notified via direct message on the applicable social media platform (Instagram, Facebook, or TikTok) used to submit the Entry. If Sponsor is unable to contact a potential winner via direct message (e.g., due to platform settings or restrictions), Sponsor may comment on the potential winner's Entry instructing the potential winner to contact Sponsor via direct message. The Sweepstakes Parties are not responsible for and shall not be liable for incorrect, changed, or illegible contact information or for any failure of a potential winner to receive notification due to privacy settings, platform limitations, or other restrictions of the applicable social media platform. Sweepstakes Parties are not responsible for late, lost, intercepted, misdirected, or unsuccessful efforts to notify the potential winner. Notification is deemed to have occurred immediately upon the sending of a direct message or comment. If the potential winner cannot be contacted within a reasonable time period, if the potential winner is ineligible, if notification is returned undeliverable, or if the potential winner otherwise fails to fully comply with these Official Rules, potential winner will forfeit that prize, and an alternate winner may be selected in a random drawing from among all remaining eligible entries. As part of the winner notification process, potential winner will be required to complete and submit a prize redemption form ("Redemption Form") within three (3) days of date of notification, as a condition of receiving the prize. Potential winner will also be required to complete, sign, and return an affidavit of eligibility and liability/publicity release (where permitted by law) (collectively, the "Declaration") within three (3) days of date of notification, as a condition of receiving the Prize. If the potential winner fails or refuses to complete and return the Redemption Form and/or Declaration within the required time period or if the Declaration is returned as rejected, faulty, unclaimed or returned as undeliverable to the potential winner, and/or the potential winner is otherwise noncompliant, such potential winner will be disqualified and an alternate will be selected, up to three (3) alternates, after which the applicable prize will remain un-awarded. The potential winner becomes a "winner" only after verification of eligibility by Sponsor.

No more than one (1) prize will be awarded. If, for any reason, more bona fide winners come forward seeking to claim the prize, the winner may be selected in a random drawing from among all persons making purportedly valid claims. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.

7. **PRIZE/PRIZE RESTRICTIONS:** The prize to be awarded in this Sweepstakes is:

One (1) Grand Prize ("Grand Prize" or "Prize"): The Prize consists of a \$50,000 cash award, awarded in the form of a check payable to the verified winner. The approximate retail value ("ARV") of the Prize is \$50,000.

Prize is non-transferable, with no substitution except at Sponsor's sole and absolute discretion. All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. Prize details and availability are subject to change and are subject to applicable rules and restrictions. In the event that Sponsor is unable to provide the Prize, Sponsor may, in its sole discretion, substitute the Prize (or any portion thereof) with a prize of equal or greater value. Prize is awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Winner is solely responsible for all federal, state, and local taxes, as well as any other costs and expenses associated with acceptance and use of the

Prize. Unclaimed prize will be forfeited. Prize, if legitimately claimed, will be awarded. The Sweepstakes Parties are not responsible for and will not replace lost, mutilated or stolen prize or if prize is undeliverable or does not reach winner because of an incorrect or changed address. If winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited, and the Sweepstakes Parties will have no further obligation with respect to prize or portion of the prize. Sponsor will attempt to fulfill properly claimed prize within approximately four (4) to six (6) weeks after winner verification.

- 8. GENERAL:** Subject to applicable law, winner hereby expressly grants to the Sweepstakes Parties and their respective successors, assigns, sublicensees and designees, the irrevocable right to use and publish his/her name, social handle, likeness (photographic or simulated), voice, biography and place of residence for all purposes, including, without limitation, advertising, marketing, promotional and publicity purposes in connection with this Sweepstakes ("Advertising"), in any and all media now or hereafter devised, worldwide, in perpetuity, without any form of notice, permission or any amount or kind of compensation, except for the awarding of the prize to the winner. All copyright, trademark or other intellectual property rights in such Advertising shall be owned by Sponsor and/or its licensors, and winner hereby disclaims and waives any claim of right to such Advertising. Such Advertising shall be solely under the control of Sponsor and/or its licensors, and winner hereby waives any claim of control over the Advertising content as well as any possible claims of misuse of winner's name, likeness or voice under contract, tort or any other theory of law. The Sweepstakes Parties do not assume any responsibility for any disruption in the Sweepstakes, including, but not limited to, the failure or interruption of any social media platform or any internet service provider. In the event there is a discrepancy or inconsistency between disclosures and other statements contained in any Sweepstakes materials and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern, and control. In the event Sponsor is prevented from continuing with the Sweepstakes by any event beyond its control, including, but not limited to, fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal, state, or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each, a "Force Majeure" event or occurrence), Sponsor shall have the right to modify, suspend or terminate the Sweepstakes or prize. Sponsor additionally reserves the right, in its sole and absolute discretion to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes.
- 9. CONDUCT:** The Sweepstakes Parties are not responsible for the actions of entrants in connection with the Sweepstakes, including entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. The Sweepstakes Parties reserve the right, at their sole discretion, to disqualify (or terminate the prize of) any individual who is found to be, or suspected of, acting in any manner deemed by the Sweepstakes Parties to be in violation of the Official Rules, or to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person, or to be tampering with the entry process or the operation of the Sweepstakes, and void all associated entries and/or registrations. CAUTION: ANY ATTEMPT BY A USER, YOU OR ANY OTHER INDIVIDUAL TO DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS, AND SHOULD SUCH AN ATTEMPT BE MADE, THE SWEEPSTAKES PARTIES RESERVE THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.
- 10. WAIVERS AND DISCLAIMERS:** The Sweepstakes Parties assume no responsibility or liability for: (a) lost, late, stolen, undelivered, inaccurate, incomplete, delayed, misdirected, damaged or garbled registrations, entries, URLs, or emails; (b) any incorrect or inaccurate entry information, or for any faulty or failed electronic data transmissions; (c) any unauthorized access to, or theft, destruction or alteration of entries or registrations at any point in the operation of this Sweepstakes; (d) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications

line failure, regardless of cause, with regard to any equipment, systems, networks, lines, cable, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (e) inaccessibility or unavailability of the Internet or the website or any combination thereof or for computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, social networking posts, or registrations, the announcement of the prize, or in any other Sweepstakes-related materials; or (f) any injury or damage to entrants or to any other person's computer which may be related to or resulting from any attempt to participate in the Sweepstakes. If, for any reason, the Sweepstakes (or any part thereof) is not capable of running as planned for reasons which may include, without limitation, infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes which may corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, then the Sweepstakes Parties reserve the right at their sole discretion to cancel, terminate, modify or suspend the Sweepstakes in whole or in part. If terminated, the Sweepstakes Parties will award the prize in a random drawing from among all non-suspect, eligible entries received for the Sweepstakes up to the time of such action.

- 11. RELEASES:** All entrants, as a condition of participation in this Sweepstakes, release, discharge, indemnify and hold harmless the Sweepstakes Parties, Facebook, Instagram, and each of their respective directors, officers, employees, agents, successors and assigns (collectively, "Released Parties") from and against any and all liability, claims, costs (including attorneys' fees), losses, damages, fines, or actions of any kind whatsoever for injuries, death, damages, or losses to persons or property which may be sustained, in whole or in part, directly or indirectly, in connection with: (i) participation in any aspect of the Sweepstakes (including travel to/from any Sweepstakes activity), (ii) the receipt, ownership, use or misuse of the prize awarded, including any travel associated with any prize, (iii) the Released Parties' violation of rights of publicity or privacy, claims of defamation or portrayal in a false light or based on any claim of infringement of intellectual property; (iv) entrant's registration material on any related website, or (v) any typographical, human or other error in the printing, offering, selection, operation or announcement of any Sweepstakes activity and/or prize.
- 12. GOVERNING LAW AND LIMITATION OF LIABILITY:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Kentucky, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

- 13. DISPUTE RESOLUTION:** The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in the State of Kentucky, and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury, and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in the State of Kentucky. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in the State of Kentucky. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.
- 14. ENTRY INFORMATION AND SWEEPSTAKES COMMUNICATIONS:** As a condition of entering the Sweepstakes, each entrant gives consent for Sponsor to obtain and deliver his or her name, address and other information to third parties for the purpose of administering this Sweepstakes and to comply with applicable laws, regulations and rules. Any information an entrant provides to Sponsor may be used to communicate with entrant in relation to this Sweepstakes or on a Sweepstakes winner's list. By participating in the Sweepstakes, entrant agrees to all of the terms and conditions of the Sponsor's Privacy Policy, which is available at https://perfettivanmelleus.com/privacy_policy/. In the event of any discrepancy between the Sponsor's Privacy Policy and these Official Rules, these Official Rules shall control and govern.
- 15. MISCELLANEOUS:** The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Entrants agree to waive any rights to claim ambiguity of these Official Rules.
