

**Homes.com Digital Online Gift Card Offer  
Terms and Conditions**

**PARTICIPATION CONSTITUTES PARTICIPANT'S FULL AND UNCONDITIONAL AGREEMENT TO THESE TERMS AND CONDITIONS, WHICH ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE OFFER.**
