1. **ELIGIBILITY:** The Kohl's Ultimate Summer Giveaway ("Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia, who are eighteen (18) years of age or older as of time/date of entry. Employees, officers and directors of Kohl's, Inc. ("Sponsor"), Realtime Media LLC ("Administrator") and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies (collectively, the "Sweepstakes Parties"), their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses, and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. By entering as set forth above, you are confirming your acceptance of and agreement to these Official Rules.

Be sure your social media account is set to public, and you are following the Sponsor’s associated social handle for at least thirty (30) days after the end of the Sweepstakes Period for winner notification purposes. Due to how the social platforms operate, Sponsor may not receive entries from entrants with “private” account settings.  - Contains any individual other than you and/or any materials embodying the names, likenesses, voices, or other indicia identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead;
 - Is not written in the English language;
 - Contains look-alikes of celebrities or other public or private figures, living or dead;
 - Communicates messages or images inconsistent with the positive images and/or goodwill to which Sponsor wishes to associate; and/or
 - Violates any law.
5. **SWEEPSTAKES DRAWING:** On or about June 15, 2026, the Administrator will perform one (1) random drawing to select two (2) potential Instagram winners from among all eligible Instagram Entries and two (2) potential TikTok winners from among all eligible TikTok Entries.
6. **ODDS:** Odds of winning an Instagram Grand Prize depend on the total number of eligible Instagram entries received. Odds of winning a TikTok Grand Prize depend on the total number of eligible TikTok entries received during the Sweepstakes Period.
7. **WINNER NOTIFICATION/PRIZE CLAIMING:** Each potential winner will be notified via direct message in a commercially reasonable time after the random drawing. The parties agree that any claim, dispute or controversy arising out of, or relating to, this agreement, or the breach thereof, shall be resolved through final and binding Arbitration to be administered by National Arbitration and Mediation ("NAM") and governed by NAM's Comprehensive Dispute Resolution Rules and Procedures in effect at the time such claim is filed. Any award of the Arbitrator is final and binding and may be entered as a judgment in any court having jurisdiction.

Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof.
