

**March Mystery Box Giveaway  
Official Rules**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES PARTIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The Kohl's March Mystery Box Giveaway ("Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia, who are eighteen (18) years of age or older as of time/date of entry. Employees, officers and directors of Kohl's, Inc. ("Sponsor"), Realtime Media LLC ("Administrator") and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies (collectively, the "Sweepstakes Parties"), their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses, and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. Void where prohibited by law. All federal, state, and local laws and regulations apply. By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these "Official Rules" and the decisions of Sponsor, including the interpretation of these Official Rules, administration of the Sweepstakes, selection of the winners, and Sponsor's exercise of discretion, which will be final, non-appealable, and binding in all respects.
2. **TIMING:** The Sweepstakes begins at or about 10:00 a.m. Eastern Time ("ET") on March 21, 2026, and ends at 11:59:59 p.m. ET on March 25, 2026 (the "Sweepstakes Period"). The designated computer clock of the Sponsor is the official time-keeping device in the Sweepstakes.
3. **HOW TO ENTER:** To participate and enter the Sweepstakes, you must have a public Instagram account. You may create an Instagram account for free by visiting the platform's website or downloading the app from your mobile device's app store. Creation of an account requires agreement and compliance with the platform's terms of service and privacy policy. If you do not agree to the platform's terms of service and privacy notice, you cannot create an Instagram account to participate in this Sweepstakes.

During the Sweepstakes Period, you may enter the Sweepstakes using the following method:

- a) **Instagram Comment:** On Instagram, take the following steps:
  - i. Log in to your Instagram account and become a follower of @Kohls account ("Instagram Handle"). Be sure your Instagram account is set to public.
  - ii. Find the Sponsor's Instagram post that promotes this Sweepstakes (the "Instagram Post").
  - iii. Then post one (1) non-offensive, non-abusive comment in response to the Instagram Post that:
    - a) Tags one (1) friend; and
    - b) @mentions one (1) of the following mystery box prize pools that you hope to win, as instructed in the Instagram Post:
      - i. LC Lauren Conrad;

- ii. Tek Gear;
- iii. FLX; or
- iv. Miryana.

For the avoidance of doubt, any @mention of more than one (1) mystery box prize pool in your Instagram Post will result in an invalid entry and not be accepted by Sponsor.

iv. Entries posted other than on the Instagram Post or otherwise not received by Sponsor will not be entered into the Sweepstakes.

If you successfully take all of these steps, you will receive one (1) entry into Sweepstakes, subject to the entry limit below.

**By entering as set forth above, you are confirming your acceptance of and agreement to these Official Rules.**

Be sure your social media account is set to public, and you are following the Sponsor's associated social handle for at least thirty (30) days after the end of the Sweepstakes Period for winner notification purposes. Due to how the social platforms operate, Sponsor may not receive entries from entrants with "private" account settings. You may return your account(s) to "private" any time after winners have been verified.

The Sweepstakes Parties are not responsible for technical difficulties of any kind, any unavailability of Instagram, or for false, incorrect, changed, incomplete or illegible contact information.

LIMIT: One (1) entry per person, per Instagram handle during the entire Sweepstakes Period. Attempts made by the same individual to earn more than the stated number of entries by using multiple or false Instagram accounts or otherwise may result in disqualification. Entries generated by script, artificial intelligence, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Those who do not include all required details in an entry or abide by these Official Rules or other instructions of Sponsor may be disqualified. Entries submitted by those who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the registered account holder of the email address associated with the social media account that posted such entry, provided that person is eligible. **4. CONTENT RESTRICTIONS:** Entries may **not** contain, as determined by the Sponsor, in its sole discretion, any content that:

- Is sexually explicit; unnecessarily violent or derogatory toward any ethnic, racial, gender, religious, professional or age group; profane or pornographic; contains nudity;
- Promotes illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing); promotes any activities that may appear unsafe or dangerous; promotes any particular political agenda or message;
- Is obscene or offensive; endorses any form of hate or hate group;
- Defames, misrepresents or contains disparaging remarks about other people or companies;

- Contains trademarks, logos, or trade dress (such as distinctive packaging or building exteriors/interiors) owned by others (other than the Sponsor), without permission;
- Contains any personal identification, such as license plate numbers, personal names, email addresses or street addresses;
- Contains copyrighted materials owned by others (including photographs, sculptures, paintings, and other works of art or images published on or in websites, television, movies or other media), without permission;
- Contains any individual other than you and/or any materials embodying the names, likenesses, voices, or other indicia identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead;
- Is not written in the English language.
- Contains look-alikes of celebrities or other public or private figures, living or dead;
- Communicates messages or images inconsistent with the positive images and/or goodwill to which Sponsor wishes to associate; and/or
- Violates any law.

5. **SWEEPSTAKES DRAWING:** On or about March 26, 2026, the Administrator will perform four (4) separate random drawings to select one (1) potential winner for each prize pool from among all eligible Instagram Entries received in accordance with these Official Rules that correspond to the applicable mystery box prize pool.

6. **ODDS:** Odds of winning a prize depend on the total number of eligible Instagram Entries received during the Sweepstakes Period.

7. **WINNER NOTIFICATION/PRIZE CLAIMING:** Each potential winner will be notified via direct message in a commercially reasonable time after the random drawing. The Sweepstakes Parties are not responsible for, and shall not be liable for, false, incorrect, changed, incomplete or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's email or any other account to receive messages or late, lost, damaged, intercepted, misdirected, or unsuccessful efforts to notify a potential winner. Notification is deemed to have occurred immediately upon sending the direct message. If a potential winner cannot be contacted within a reasonable time period, if potential winner is ineligible, if any notification is returned undeliverable, or if a potential winner otherwise fails to respond and fully comply with these Official Rules, potential winner will forfeit that prize and an alternate winner may be selected from among all remaining eligible Entries. **Prize Pool 3 – FLX Box:** One (1) prize consisting of a mystery box containing a selection of FLX branded apparel and products, as determined by Sponsor in its sole discretion. Winner will select either a men’s or women’s box, subject to availability. ARV: up to \$125.

**Prize Pool 4 – Miryana Box:** One (1) prize consisting of a mystery box containing a selection of Miryana branded bedding and products, as determined by Sponsor in its sole discretion. Winner will be able to select applicable bedding size, subject to availability. ARV: \$210.

Specific items included in each mystery box will be determined by Sponsor in its sole discretion. Sizes will be selected by the applicable winner where applicable.

The total ARV of all prizes available in the entire Sweepstakes is \$583.

Prizes are non-transferable, with no cash redemptions, equivalents, or substitutions except at Sponsor’s sole and absolute discretion. The Sweepstakes Parties do not assume any responsibility for any disruption in the Sweepstakes, including, but not limited to, the failure or interruption of any social media platform or any internet service provider. Sponsor additionally reserves the right, in its sole and absolute discretion to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes.

**10. CONDUCT:** The Sweepstakes Parties are not responsible for the actions of entrants in connection with the Sweepstakes, including entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. DISPUTE RESOLUTION:** The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the United States District Court for the Eastern District of Wisconsin, and the courts of the State of Wisconsin sitting in Waukesha County, for any action, litigation, or proceeding arising from or relating to this Agreement. The parties agree that any claim, dispute or controversy arising out of, or relating to, this agreement, or the breach thereof, shall be resolved through final and binding Arbitration to be administered by National Arbitration and Mediation ("NAM") and governed by NAM's Comprehensive Dispute Resolution Rules and Procedures in effect at the time such claim is filed. Any award of the Arbitrator is final and binding and may be entered as a judgment in any court having jurisdiction.

**15. ENTRY INFORMATION AND SWEEPSTAKES COMMUNICATIONS:** As a condition of entering the Sweepstakes, each entrant gives consent for Sponsor to obtain and deliver his or her name, address and other information to third parties for the purpose of administering this Sweepstakes and to comply with applicable laws, regulations and rules. - 16. MISCELLANEOUS:** The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Entrants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on any website, social media platform or application and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
