

**M&M's Sweet Fan Ticket Sweepstakes
Official Rules**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES PARTIES (AS DEFINED BELOW) FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The M&M's Sweet Fan Ticket Sweepstakes ("Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia, who are eighteen (18) years of age or older as of date of entry. Employees, officers and directors of Mars Wrigley Confectionery US, LLC ("Sponsor"), Mars United Commerce, Realtime Media LLC ("Administrator"), Disney Worldwide Services, Inc. dba D23 Worldwide and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies, and each of their respective affiliates, owners, subsidiaries, shareholders, officers, directors, agents, representatives and employees, both individually and collectively), and each of its their affiliates, franchisees, franchise employees, agencies, shareholders, officers, directors, members, successors, agents and assigns, (collectively, the "Sweepstakes Parties"), their respective IRS dependents, immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses, and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. Void where prohibited by law. All applicable federal, state, and local laws and regulations apply. By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these "Official Rules" and the decisions of Sponsor, including the interpretation of these Official Rules, administration of the Sweepstakes, selection of the winners, and Sponsor's exercise of discretion, which will be final, non-appealable, and binding in all respects.
2. **TIMING:** The Sweepstakes begins at or about 9:00 a.m. Eastern Time ("ET") on June 16, 2026, once the Sweepstakes Post (as defined below) is published as set forth below, and ends at 11:59:59 p.m. ET on July 3, 2026 (the "Sweepstakes Period"). The designated computer clock of the Sponsor is the official time-keeping device in the Sweepstakes.
3. **HOW TO ENTER:** To participate and enter the Sweepstakes, you must have a non-private Facebook and/or Instagram account. You may create a Facebook or Instagram account for free by visiting the respective platform's website or downloading the applicable app from your mobile device's app store. Creation of an account requires agreement and compliance with the platform's terms of service and privacy policy. If you do not agree to the applicable platform's terms of service and privacy notice, you cannot create a Facebook account and/or an Instagram account to participate in this Sweepstakes. During the Sweepstakes Period, you may enter the Sweepstakes using the following methods:
 - A. **Facebook Comment:**
 - i. Become a follower of the M&M'S USA Facebook page (www.facebook.com/mms) ("Facebook Page"). **Be sure your Facebook account is set to public.**

- ii. Find the Sponsor's Facebook post that promotes this Sweepstakes (the "Facebook Post") and post one (1) non-offensive, non-abusive comment in response to the Facebook Post that includes the hashtag "#MMSSweepstakes2026" (collectively, your "Facebook Entry").
- iii. Entries posted other than on the Facebook Post or otherwise not received by Sponsor will not be entered into the Sweepstakes. If you successfully take all of these steps, you will receive one (1) entry into Sweepstakes, subject to the entry limit below.

B. Instagram Comment: On Instagram, take the following steps:

- i. Log in to your Instagram Account and become a follower of the @mmschocolate Instagram account ("Instagram Handle"). **Be sure your Instagram Account is set to public.**
- ii. Find the Sponsor's Instagram post that promotes this Sweepstakes (the "Instagram Post"), and post one (1) non-offensive, non-abusive comment in response to the prompt in the Instagram Post that includes tagging a friend and the hashtag "#MMSSweepstakes2026" (collectively, your "Instagram Comment").
- iii. Instagram Comments posted other than on the Instagram Post or otherwise not received by Sponsor will not be entered into the Sweepstakes. If you successfully take all of these steps, you will receive one (1) entry into Sweepstakes, subject to the entry limit below.

By participating as described above, you are confirming your acceptance of and agreement to these Official Rules.

Your entry must be suitable for public viewing and must communicate messages consistent with the positive images and goodwill to which Sponsor wishes to associate. Your entry must not include the consumption of alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing); promote any activities that may appear unsafe or dangerous; or promote any particular political agenda or message. Do not use content, image, or video that is not your own. Any entry that includes trademarks, logos, copyrighted materials owned by others, or any personally identifiable information may be disqualified.

All entries must be posted by 11:59:59 P.M. ET on July 3, 2026 to be included in this Sweepstakes. Entries not received by Sponsor will not be entered into the Sweepstakes.

Sponsor may not receive entries that fail to strictly follow the exact instructions set forth in these Official Rules, and Sponsor is not responsible for failure to see or receive an entry. Sponsor, at its sole discretion, may accept a technically incorrect hashtag term. NOTE: Sponsor may not receive entries from users with "private" account settings (i.e., you have set your social media account so that only people you have approved can view your posts) due to the way both platforms operate their services. Be sure your social media account is set to "public" and you are following the Sponsor's associated social handle for at least thirty (30) days after the end of the Sweepstakes Period for winner notification purposes. You may return your account(s) to "private" any time after winners have been verified.

NOTE: If participating in the Sweepstakes via a mobile device, message and data rates may apply. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless provider's pricing plans.

The Sweepstakes Parties are not responsible for technical difficulties of any kind, or for unavailability of the Instagram platform or any service interruption.

LIMIT: One (1) entry per person per entry method for a total of up to two (2) total entries during the entire Sweepstakes Period. Attempts made by the same individual to earn more than the stated number of entries by using multiple or false Facebook and/or Instagram accounts or otherwise may result in disqualification. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means or using artificial intelligence ("AI") in order to subvert the entry process are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, inaccurate, lost, late or misdirected, deceptive or

otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Those who do not follow all instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified, and all associated entries will be void. Entries submitted by those who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the registered account holder of the social media account associated with such entry, provided that person is eligible and complies with the Official Rules. Any potential winner may be required to show proof of being the registered account holder, based on the email address associated with the social media account in question. Registered account holder is defined as the person assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. In the event that a dispute regarding the identity of the individual who submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

4. **SWEEPSTAKES DRAWING:** On or about July 6, 2026, the Administrator will conduct a random drawing to select two (2) potential winners from among all eligible entries received in accordance with these Official Rules.
5. **ODDS:** Odds of winning a prize depend on the total number of eligible entries received during the Sweepstakes Period.
6. **WINNER NOTIFICATION/PRIZE CLAIMING:** Each potential winner will be notified via direct message in a commercially reasonable time after the drawing. If a potential winner entered on Facebook, Sponsor may post a comment on the potential winner's Facebook Entry asking the potential winner to send the Sponsor a private message if the Sponsor cannot send a message directly. The Sweepstakes Parties are not responsible for and shall not be liable for incorrect, changed, or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering, or insufficient space in entrant's email or other account to receive messages. Sweepstakes Parties are not responsible for late, lost, intercepted, misdirected, or unsuccessful efforts to notify a potential winner. Notification is deemed to have occurred immediately upon the sending of the direct message. As part of the winner notification process, each potential winner will be required to complete and submit a prize redemption form ("Redemption Form") and sign and return a declaration of eligibility/release of liability/prize acceptance agreement ("Declaration") within five (5) days of Sponsor's time stamp of sending, as a condition of receiving a prize. The value of the prize awarded to a winner will be reported for tax purposes as required by law. Each winner will be required to provide Sponsor with a valid social security number before the prize will be awarded for tax reporting purposes. An IRS Form 1099 will be issued in the name of each winner for the actual value of the prize received. If a potential winner cannot be contacted within a reasonable time period or any notification is returned as undeliverable, if a potential winner fails or refuses to complete, sign, and return the Redemption Form and/or Declaration within the required time period, and/or if any potential winner is deemed ineligible or noncompliant with these Official Rules or any of Sponsor's instructions, such potential winner will forfeit the prize and be disqualified, and an alternate will be selected, time permitting, in a random drawing from among all remaining eligible entries received. Up to three (3) alternates will be selected for a prize, after which the applicable prize will remain un-awarded. A potential winner becomes a "winner" only after verification of eligibility by Sponsor.

In the event a selected winner is a resident of Alabama or Nebraska and under the age of nineteen (19), a parent or legal guardian may be required to also sign the Declaration in order for the winner to be qualified to receive the prize.

No more than the stated number of prizes will be awarded. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number prizes set forth in these Official Rules, the winners of the advertised number of prizes available may be selected in a random drawing from among all persons making purportedly valid claims for such prizes. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.

7. PRIZES/PRIZE RESTRICTIONS: The prizes available to be awarded in this Sweepstakes are:

Two (2) Prizes: Each prize is a five (5) day/four (4) night trip for two (2) people – the winner and one (1) guest – to Anaheim, California to attend the D23: The Ultimate Disney Fan Event at the Anaheim Convention Center scheduled to occur August 14 – 16, 2026 (the “Event”). Prize includes round-trip coach class airfare for the winner and guest between a major commercial airport near the winner’s residence (as determined by Sponsor) and Los Angeles International Airport (“LAX”), four (4) nights standard hotel accommodation (single room, double occupancy), One Thousand and 00/100 Dollars (\$1,000.00 USD) awarded to the winner in the form of a check, and two (2) Event passes for August 14, 15, and 16, 2026 to D23: The Ultimate Disney Fan Event at the Anaheim Convention Center only for the winner and guest. The approximate retail value (“ARV”) of each prize is approximately \$5,820. The actual value of a prize may vary depending on point of departure, fluctuations in the cost of air transportation and fluctuations in the cost of hotel accommodation. Any difference between the ARV and the actual value of the prize will not be awarded.

Travel must be taken on dates specified by Sponsor and is expected to be August 13 – 17, 2026. Winner and guest must travel on the same itinerary. If a winner resides within a 200-mile radius of Anaheim, California, as determined by Sponsor in its sole discretion, ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in prize value. Each winner and their guest are responsible for having valid travel documents including a REAL ID or other government-issued identification approved for air travel. All airline tickets are subject to flight variation, work stoppages, and schedule or route changes. Sponsor reserves the right to structure travel routes, select hotels, and all other aspects of a prize in their sole and absolute discretion. Each winner is responsible for all travel expenses not included herein, including airline baggage fees, gratuities, meals, and any other incidental costs or expenses related to participation in the prize. In the event a winner elects to take part in their prize with no guest, no additional compensation will be awarded in lieu of the unused prize components. Once a guest is selected, he/she may not be substituted, except in Sponsor’s sole and absolute discretion. Each guest must be at least eighteen (18) years of age as of the date of departure or be the winner’s child/legal ward. Each guest (or the guest’s parent/legal guardian in the event of a minor) must sign and return a travel liability and publicity release before travel will be booked. Each winner and their guest hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of a prize. No changes will be made to travel details once any element of the travel arrangements have been booked, except at Sponsor’s sole discretion. Each winner will be required to provide a major credit card upon hotel check-in, and all in-room charges will be charged to the credit card. Any damage to the room will be the responsibility of such winner. Sponsor bears no responsibility if any event, element, or detail of a prize is canceled, postponed, or becomes unavailable for any reason whatsoever by the air carriers, hotels, venue operators, transportation companies, prize providers or any other persons providing any prize-related services or accommodations. Winner agrees that Event passes are awarded pursuant to a revocable, nontransferable license that is personal to that applicable winner, and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed. The Event operator reserves the right in its sole discretion to remove or to deny entry to any winner and/or their guest if either winner or guest violates the previous restrictions or engages in an obnoxious, inappropriate, illegal, unsafe, or otherwise disruptive manner, or with intent to create an unauthorized disturbance or interruption, or to otherwise annoy, abuse, threaten or harass any other person at the Event.

Total ARV of all prizes available in the Sweepstakes is \$11,640.

Prizes are awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Each winner will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the prize received, regardless of whether it, in whole or in part, is used. The ARV of the prizes is based on available information provided to Sponsor as of the time these Official Rules are printed and may fluctuate. Any unclaimed prize will be forfeited. Prizes, if legitimately claimed, will be awarded. The Sweepstakes Parties are not responsible for and will not replace any lost, mutilated, or stolen prize or any prize that is undeliverable or does not reach a winner because of an incorrect or changed address. If a winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited, and the Sweepstakes Parties will have no further obligation with respect to that prize or portion of the prize. The Sweepstakes Parties are not responsible for, and winner will not receive the difference, if any, between the actual value of the prizes at the time of award and the stated ARV in these Official Rules or in any Sweepstakes-related correspondence or material. Limit of one (1) prize per person/household. Sponsor's designee will contact each winner upon verification to arrange travel booking.

- 8. PUBLICITY GRANT:** Subject to applicable law, each winner hereby expressly grants to the Sweepstakes Parties and their respective successors, assigns, sublicensees and designees, the irrevocable right to use and publish his/her name, social handles, likeness (photographic or simulated), voice, biography and place of residence for all purposes, including, without limitation, advertising, marketing, promotional and publicity purposes in connection with this Sweepstakes ("Advertising"), in any and all media now or hereafter devised, worldwide, in perpetuity, without any form of notice, permission or any amount or kind of compensation, except for the awarding of the prizes to the winners. All copyright, trademark or other intellectual property rights in such Advertising shall be owned by Sponsor and/or its licensors, and each winner hereby disclaims and waives any claim of right to such Advertising. Such Advertising shall be solely under the control of Sponsor and/or its licensors, and each winner hereby waives any claim of control over the Advertising content as well as any possible claims of misuse of winner's name, likeness or voice under contract, tort or any other theory of law.

CONDUCT:** The Sweepstakes Parties are not responsible for the actions of entrants in connection with the Sweepstakes, including entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity, or proper conduct of the Sweepstakes. Sponsor additionally reserves the right, in its sole and absolute discretion to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes.

RELEASES:** All entrants, as a condition of participation in this Sweepstakes, release, discharge, indemnify and hold harmless the Sponsor, Sweepstakes Parties, Meta Platforms, Inc., and each of their respective directors, officers, employees, agents, successors and assigns (collectively, "Released Parties") from and against any and all liability, claims, costs (including attorneys' fees), losses, damages, fines, or actions of any kind whatsoever for injuries, death, damages, or losses to persons or property which may be sustained, in whole or in part, directly or indirectly, in connection with: (i) participation in any aspect of the Sweepstakes (including travel to/from any Sweepstakes activity), (ii) the receipt, ownership, use or misuse of the prize awarded, including any travel associated with any prize, (iii) the Released Parties' violation of rights of publicity or privacy, claims of defamation or portrayal in a false light or based on any claim of infringement of intellectual property; (iv) entrant's registration material on any related website, or (v) any typographical, human or other error in the printing, offering, selection, operation or announcement of any Sweepstakes activity and/or prize.
- 12. GOVERNING LAW AND LIMITATION OF LIABILITY:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of New Jersey, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.
